Common Policy Topics (1/5)

- Internet Assigned Number Authority (IANA) for Allocation of ASN Blocks to RIRs, ratified by ICANN in September 2010
 - ripe-480 is implemented in the RIPE NCC Service Region
 - 32-bit ASN block only from 1 Jan 2011

Common Policy Topics (2/5)

- IPv4 Depletion
 - APNIC: entered Stage Three of IPv4 address block exhaustion
 - AfriNIC: Soft Landing Policy approaching the Last Call with new version

Common Policy Topics (3/5)

- IPv4 Depletion
 - ARIN: set aside /10 (NRPM 4/10)
 - LACNIC: allocation policy activated when the last /12 address pool is in use

Common Policy Topics (4/5)

- IP Resources Transfer
 - AfriNIC: two proposals on transfer outside the AfriNIC region
 - APNIC: consensus on “Inter RIR IPv4 address transfer proposal”

Common Policy Topics (5/5)

- IP Resources Transfer
 - ARIN: “Globally coordinated transfer policy”, back to PPML after ARIN XXVII
